Guadalupe I. Lopez, elected to the Bexar Metropolitan Water District (District 1) on November 4, 2008, took her oath of Office on November 17th. She represents the community in the South San Antonio Independent School District (SSAISD) area, the Harlandale ISD area and the Edgewood ISD area on the Westside. Ms. Lopez's career ranged from kindergarten education, to elementary primary grades to administration at the secondary level. She retired after 27-years in the educational field.

Ms. Lopez, a lifelong resident of South San Antonio, served her community in numerous capacities including but not limited to: charitable organizations, community neighborhood groups and political activities. She has been an advocate for many causes and has supported numerous elected officials who also serve their constituency.

Her education background includes a diploma from South San Antonio High School and attendance at San Antonio College. She later earned a Bachelor of Science from East Texas State University and earned her Master of Arts from the University of Texas at San Antonio (UTSA). She also has acquired post graduate education from UTSA.
